**Aim:** The Bennington Bookshop (the Bookshop) supports authors through its consignment program. The aim of the consignment program is to feature a wide range of books published independently or through non-traditional channels and offer these books for sale to a wider audience.

At the end of the consignment period, the Bookshop will reconcile the items on consignment and send any payment resulting from the sale of books to the address provided below by the consigner. The Bookshop will notify the consigner to pick up any remaining books. The consigner may pick the books up in person, or make shipping arrangements and pay any shipping fees. The Bookshop will only pay for books that were sold. The consigner assumes sole responsibility for damaged or stolen items. Any books not picked up after **30 days** from the end of the agreement will be donated or given away.
